1. The Administrator of the personal data provided in the Statement is: Live Sp. z o.o. Piastowska 67 Street, 80-363 Gdańsk.
2. The processing of the Personal Data of the Guardian and the Personal Data of the Minor Participant provided to the Administrator in the Statement is voluntary, but necessary for the Minor Participant to take part in the RED BULL BC ONE WORLD FINAL 2021 event in Gdańsk (hereinafter the "Event").
3. The processing of personal data takes place solely for the purpose of concluding and performing the Agreement for participation in the Event. The legal basis for data processing is the provision of Art. 6 sec. 1 lit. b of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (general regulation on data protection), NS. U. UE. L. of 2016, No. 119, p. 1 as amended. d. - hereinafter referred to as "GDPR").
4. Personal data may be transferred to entities cooperating with us providing services, including accounting, IT.
5. Personal data will be stored for the duration of the Event, and after its completion - until the expiry of the limitation period for possible mutual claims of the Parties.
6. You have the following rights:
 - a. The right to access personal data,
 - b. The right to rectify personal data,and, in the cases and under the terms of the GDPR:
 - a. The right to request the deletion of personal data,
 - b. The right to limit the processing of personal data,
 - c. the right to transfer personal data,
 - d. the right to object to the processing of personal data.
